#### Grant Committee Activities - Cy Alba

The 2018-2019 Grant Program is running far ahead of this time last year. So far this fraternal year, your VKCCI Grant Committee has received 33 grant requests, 26 have been approved, 1 disapproved, and 6 were withdrawn, after further investigation. We have approved \$72,859.72 in grants. Four were KOVAR funded. We have already awarded over \$18,750 more than last year at this time.

To continue this level of assistance, it is critical that individual Brother Knights <u>respond</u> <u>generously</u> to the label program mailings and the Golf Ball Drop, and that all Councils <u>contribute faithfully</u> to the annual Council contribution program. Your contributions help us provide assistance to Virginia residents in need of immediate financial assistance.

#### **Report of Grants Issued since the last Newsletter:**

A \$416.36 grant to assist a 15-year old boy with cerebral palsy who is confined to a wheelchair. The grant would repair the wheelchair lift on the family's wheelchair accessible van.

A \$2,789.32 grant to assist a 63-year old disabled woman with deteriorating medical conditions which caused her to forgo several monthly bills to pay urgent medical co-pays and bills.

A \$1,100 grant to assist a 75-year old woman who recently suffered kidney failure and is now on dialysis. Her doctors recommended she abandon her walker and obtain a wheelchair to improve her mobility. The home has exterior stairs. The grant would provide the funds to purchase materials for a wheelchair ramp. The council will provide the engineering and manpower to build the ramp.

A \$2,650 grant to assist a Brother Knight with several overdue bills (rent, medical, utilities, etc.). He had fallen behind when he lost his fulltime job. Grant paid his bills until he received his first paycheck at his new job.

An \$875 grant to assist an adult Special Olympian obtain needed dental work, including restorations and a root canal. This is a KOVAR funded grant.

A \$4,000 grant to assist a family with severe medical issues relocate to a new house, after their current house was damaged with river flood waters caused by hurricane Michael. The entire first floor was flooded with 3-5 feet of water, destroying all their belongings on the first floor.

A \$2,000 grant to assist a young family who had just gone through a difficult pregnancy. The wife had to quit work early, and the father lost his job due to excessive absences to take care of his wife. The grant would pay for overdue rent and utility bills.

DISAPPROVED. A \$4,000 grant to assist a Brother Knight with five-month overdue mortgage payments was disapproved. Committee felt the situation was hopeless, as the overdue mortgage was just the tip of the indebtedness iceberg. Brother Knight bears some responsibility for letting situation get out of control.

A \$4,000 grant to assist a Brother Knight on disability and suffering through another bout of cancer with some overdue rent, utilities, and medical bills. The grant would also fund a wheel chair ramp for his van. He has 4 children under the age of 10 living at home.

A \$4,000 grant to assist a Brother Knight who is unable to work for a couple of months due to complications following spinal surgery. The grant would assist with rent, utilities, and health insurance.

A \$4,500 grant to assist the Little Sisters of St. Francis replace the clothing of 10 intellectually disabled men, whose group home suffered catastrophic losses in a fire. The men lost all their clothing and furnishings in the fire. The sisters manage the home. This is a KOVAR funded grant.

A \$1,566 grant to assist the widow of a Brother Knight repair her kitchen floor which has rotted out, causing significant risk of injury.
